CITIC Resources Holdings Limited (the “Company”) is pleased to announce that, at the annual general meeting of the Company held at Suites 6701-2 & 08B, 67/F., International Commerce Centre, 1 Austin Road West, Kowloon, Hong Kong on 14 June 2024 (the “AGM”), all the proposed resolutions as set out in the notice of the AGM dated 26 April 2024 were duly passed by the shareholders of the Company by way of poll.

As more than 50% of the votes were cast in favour of each of the resolutions numbered 1 to 5C, all such resolutions were duly passed as ordinary resolutions of the Company.

As at the date of the AGM, there were a total of 7,857,727,149 issued and fully paid shares (the "**Shares**") of the Company. The total number of Shares held by shareholders of the Company (the "**Shareholders**") able to attend and vote for or against the resolutions proposed at the AGM were 7,857,727,149 Shares. There was no restriction on any Shareholder casting votes on any of the resolutions at the AGM. There were no Shares entitling the holders thereof to attend and abstain from voting in favour of the resolutions proposed at the AGM as set out in Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "**Listing Rules**"), and no Shareholder was required under the Listing Rules to abstain from voting on any of the resolutions at the AGM. No parties have indicated in the circular containing the notice of the AGM that they intend to vote against or to abstain from voting on any of the resolutions at the AGM.

The share registrar of the Company in Hong Kong, Tricor Tengis Limited, acted as scrutineer for the purpose of taking votes at the AGM.

All directors of the Company attended the AGM in person.

2023 FINAL DIVIDEND

The Company will distribute a final dividend of HK2.50 cents per Share for the year ended 31 December 2023 (the "**Final Dividend**") to the Shareholders whose names appear on the register of members of the Company on Monday, 24 June 2024. For determining the entitlement of the Shareholders to receive the Final Dividend, the register of members of the Company will be closed from Thursday, 20 June 2024 to Monday, 24 June 2024, both days inclusive, during which period no transfer of Shares will be registered. For the purpose of ascertaining the Shareholders' entitlement to the Final Dividend, all transfers of Shares accompanied by the relevant share certificates must be lodged with the branch share registrar of the Company in Hong Kong, Tricor Tengis Limited at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong, not later than 4:30 p.m. on Wednesday, 19 June 2024. The Final Dividend is expected to be paid to entitled shareholders on or around Thursday, 18 July 2024.
